

Financial Risk Management in Crisis

Agile redesign efforts to identify, assess and execute changes in Federal Rules and Regulations will minimize response time and reduce financial risk. Agile redesign efforts for process, technology and staff include three key areas.



Payments and Reimbursements

Design & execute proper tracking and reconciliation related to advanced/accelerated Medicare payments and reimbursement for testing, diagnosis and treatment of COVID-19.



Diagnosis and Procedure Coding

Adjust Processes, Technology and Staffing to address new billing rules for COVID 19 treatment, including new diagnosis codes, CPT codes, modifiers and place of service requirements.



CMS Submissions

Identify and submit individual waivers for the Emergency Medical Treatment and Labor Act (EMTALA), as well as relaxed reporting guidelines and requests for advanced / accelerated Medicare payments.
